

Back Injury Claim

£9,000 Compensation For Wrexham Man After Fall At Work

PSR Solicitors at Wrexham have successfully obtained over £9,000.00 for an employee who suffered injury following a fall at work. Our client was working at a factory in Hampshire and he was cleaning machinery. The hosepipe our client was using became stuck on a step and our client slipped and fell when trying to free the hosepipe.

Liability for the accident was admitted by the Defendant's insurance company and following the admission we obtained our client's medical records and then arranged for him to be examined by a medical expert. Once the medical evidence had been approved by our client negotiations took place regarding the value of our client's claim and a favourable settlement of over £9,000.00 was achieved.



Elbow Injury Claim

£8,000 Compensation After Work Accident With Knife

In August our client was working at his place of employment in Upton in Chester. Although his employment duties were ground worker related, he was instructed to help out the other colleagues by cutting plasterboard. Our client was provided with a Stanley knife to do so, however was provided with no training regarding the use of a Stanley knife when cutting plaster board.

Whilst using the knife he cut the boards towards himself and whilst doing so the Stanley knife slipped and lacerated his left inner elbow. Our client was attended by the first aider and then attended hospital.

We sought to negotiate quantum with the defendants, however only received an offer of £4200.00 which we deemed to be too low. As such, we issued Court proceedings against the Defendants and thereafter made a Request to Enter Judgement in the County Court. Judgement was entered strengthening our client's position. As a result, our client obtained £8,000 compensation for his pain, suffering and loss of amenity.

Leg Injury For Passenger Thrown From Train

Compensation Award After Injury On A Miniature Train

PSR Solicitors have successfully obtained £1,250.00 for a Client who was injured when a miniature train he was riding on derailed resulting in him being thrown to the ground. Our Client and his son were passengers on the miniature railway train when the rear carriage derailed and they were both thrown on to the ground. Fortunately our client's young son was uninjured. As a result of the accident our client sustained injury to his right arm, right elbow and right lower leg. Fortunately our client's symptoms resolved within a few weeks.

Liability for the accident was admitted by the Defendant's insurance company. They made our Client a pre-medical offer in the sum of £1,250.00 which our client wished to accept.



Serious Injuries Changed Clients Life

£100,000 Compensation For Run Over Pedestrian

PSR Solicitors of Wrexham successfully completed a compensation claim for a lady who was run down by a driver while she was shopping in a local market.

As a result of the accident our client sustained life changing injuries. The case was admitted by the Defendant's Insurers and we arranged for our Client to be medically examined. Medical evidence was obtained along with treatment on a private basis before any settlement was completed. We also arranged for an Occupational Therapist to visit our Client's home and advise upon the amendments required within her home to ensure that she was able to remain as independent as possible.

Once treatment had been concluded and all the evidence had been obtained, settlement negotiations commenced and a Barrister was instructed to value the case. Eventually a settlement was agreed in excess of £100,000.

Upon conclusion of the case the family of the Claimant were very appreciative of the work PSR Solicitors did and commented that we really did our best for them at a very difficult time.
